Re: Bankruptcy Noticing Center (BNC) Enhancement to the Court's Mailing Matrix

The Clerk's office is pleased to announce an important enhancement which will assist courts and case participants with noticing from the ECF mailing matrix. On January 8, 2007, the BNC introduced an enhancement to the Court's Mailing Matrix to identify a Creditor's Preferred Address Request submitted to the National Creditor Registration Service (NCRS) pursuant to 11 U.S.C. § 342 and Fed.R.BankP. 2002 (g)(4). In addition, the enhancement also identifies duplicate or undeliverable addresses on the mailing matrix.

When a user produces a "Mailing Matrix by Case" from the Court's ECF database, any address which is a "Preferred Address" (with the NCRS) will be indicated on the matrix with a (p) and the preferred address will be substituted for the original address provided by the debtor. However, the original address will be indicated at the end of the matrix list with an indication of the substitution. Any address on the matrix which is a duplicate or an incomplete address, will also be indicated at the end of the matrix list showing a (d) for duplicate address or (u) undeliverable. Please see the attached example matrix showing examples of the enhancements.
