



General Order 14-001 Adoption of Amended Local Rules (2014)

This General Order Number 14-001 is issued by the United States Bankruptcy Court for the District of Utah Pursuant to 28 U.S.C. § 2071, Federal Rules of Civil Procedure 83, Federal Rules of Bankruptcy Procedure 9029, District Court Local Civil Rule 83-7-4, and [Bankruptcy Local Rule 1001-1\(c\)](#) [1]. Proposed amendments to the local rules of practice were published for comment and the comment period has expired and the United States District Court for the District of Utah has reviewed and approved the amended Local Rules as set forth in the District Court General Order

14-007. Accordingly,
